Any request for extension of time shall be considered solely at the discretion of STC and shall be effective only if approved in writing.

3. In accordance with Clause 16 of the Instructions to Bidders (ITB) of the RFP, as amended from time to time, you are required to furnish an unconditional and irrevocable Performance Bank Guarantee (PBG) equivalent to two percent (2%) of the Accepted Contract Price, rounded off to the nearest thousand Indian Rupees, amounting to INR 16,29,000 (Rupees Sixteen Lakh twenty-nine thousand Only). The Performance Bank Guarantee shall be submitted in the prescribed format through a Nationalised Bank or Scheduled Commercial Bank in India in favour of the Chief Executive Officer, State Transformation Commission, Government of Uttar Pradesh, payable at Lucknow, within Fifteen (15) days from the date of issuance of this Letter of Award and prior to execution of the Consultancy Agreement. The Performance Bank Guarantee shall remain valid for the entire Contract Period, including any extension thereof, together with a claim period of sixty (60) days beyond completion of all contractual obligations, unless otherwise provided in the RFP.

Upon submission of the Performance Bank Guarantee and fulfilment of all requisite pre-contract formalities prescribed under the RFP, the Consultancy Agreement shall be executed in the format prescribed by STC within Fifteen (15) days from the date of issuance of this Letter of Award, in accordance with Clause 15 of the Instructions to Bidders (ITB) of the RFP.

5. The date of commencement of the assignment shall be as specified in the Consultancy Agreement.

Failure to comply with the requirements of this Letter of Award or the provisions of the RFP, including submission of the Performance Bank Guarantee and execution of the Consultancy Agreement within the prescribed timelines, may result in withdrawal of this Letter of Award and such other action as STC may deem appropriate under the RFP, the Consultancy Agreement and the applicable laws, rules and Government instructions.
